Aims and Objectives

- To bring everlasting change among marginalized communities towards their better quality of life.
- To work towards eliminating social inequalities and strengthening the economic capacities and capabilities of the above captioned communities.
- To make efforts for ensuring genuine entitlements from the government bodies and others to the eligible.
- To maintain environment friendly climate and cleanliness in the place they live and around.
- To bring in awareness of good habits and practices in the community for a healthy and happy living.
- To bring in awareness of the value of education in the community and raise literacy levels.

Activities of the society

The activities of the society are broadly classified to as following:

- A. Educational activities.
- B. Health activities
- C. Community development activities.
- D. General

- A. To promote adult literacy and to make all efforts for formal and vocational education among educationally and socially marginalized section of society
- B. To help to the deserving students of socially and educationally marginalized section of society
- C. To manage and administer orphanage, old age home, nursing home, hospital, library, reading room, trust, school, college other institutions.
- D. To work for the development of rural, urban, tribal, poor, helpless deprived, old aged citizen, woman, widows handicapped people for all round development in the field of education, shelter, health with special emphasis for marginalized and deprived people
- E. To manage, encourage and maintain, Mobile health care centre, Health education and training center, eye camp, vaccination camp, family welfare (Population Control), Pulse polio drop distribute Centre, blood & organ donation and familiarize people to control AIDS, Cancer, Kalazar, T.B. etc. from the society .
- F. To provide drinking water, clothes and other minimum necessities to suffering people during odd hours and particularly during summer and winter seasons.
- G. To eradicate social evils like dowry, child marriage, casteism superstition, drug—addiction etc and encourage inter caste marriage, widow re-marriage and social harmony in the society.
- H. To affirmatively work and coordinate with the State and Central Govt. and other NGOs in formulation and implementation of developmental schemes benefiting to Society.
- I. To work for the betterment of women, senior citizen and handicapped and to fight against social wrongs like discrimination and harassment based on gender, caste, religion and economic disparities etc .
- J. To fight against corruption and make people conscious about their legal rights and privileges enshrined in Constitution and Directive Principle of State.
- K. To run plantation program for controlling and protection of environment and aware people to plant all types of trees and give knowledge of non-conventional energy, solar energy, water energy, air energy and arrange solar energy in the rural area.
- L. To access and participate in the of Government, local body, banks, financial & insurance institutions and other legally constituted bodies engaged to promote Society's objectives.
- M. To organize training for agricultural, animal husbandry, rural artisan, handloom, handicraft and allied activities and canvass Mass awareness in villages through consulting people's organization and related Govt. functionaries.
- N. To work for freedom of liberty, equality and the pursuit of happiness of life for all people of society.
- O. To appoint or employ temporarily or permanently any person for the purpose of the society and to pay them salary or wages as may be determined by the Governing Council.
- P. To do all such other lawful act, deeds and things as are incidental and conducive to the attainment of the objects or any of them.
- Q. To receive and collect any gifts, subscriptions and donations either in cash or in kind or acquire by any other lawful ways and means and spend the same in fulfillment of all or

any of the aims and objects of the society. The income and properties of the society shall be applied solely for the promotion and fulfillment of the aims and objects of the society.

- R. To issue appeals for and collect money and goods in kind and to organize concerts, exhibitions, sports events or entertainments of any kind for the purposes of raising funds for carrying out the objects of the Society.
- S. To acquire by purchase, take on lease, hire or by gift or otherwise and hold any movable or movables and also any immovable property or properties or any rights or privileges that may be deemed necessary or useful for the advancement of objects of society or any of them and other enterprises with the cooperation and assistance of Government and other agencies.
- T. All the income, earning, movable or immovable properties of the society shall be solely utilized and applied towards promotion of its aims and objectives only set out in the memorandum of association and no portion shall be paid or transferred directly or indirectly by way of dividend, bonus, profit or in any manner whatsoever, to the present or past members or past member. No member of the society shall have any personal claim on any movable or immovable properties of the society or make any profit, whatsoever, by virtue of his/her membership.
- U. To take over, absorb or amalgamate with any other society or association or institution whose objects are similar to the objects of the society.
- V. All the affairs of the Society shall be conducted according to the provisions of the rules and regulations framed by the society and the same may be amended, enlarged or improved by the society.
- W. Without prejudice to the generally to the above objects and for effectively carrying out the same the society shall have power to receive, hold and possess any property including securities of any kind and to construct and maintain any building, to manage, transfer or otherwise dispose of or deal in any property or security and to enter into any contract for or in connection with the purposes of the society to raise the money and funds for benefits of the employees of the society and to accept the Management of any trust or endowment in which the society may be interested.
